## AREA/DIRECTIONAL LIGHTING RATE SCHEDULE

### (Name of Schedule)

**AVAILABLE:** In the retail distribution service territory of the District.

**APPLICABLE:** To area/directional lighting of farmyards, backyards, patios, parking lots, storage yards, trailer courts, industrial sites, schools, churches, apartments, businesses, and many other applications where lighting is needed for identification, merchandising, environment, aesthetics, safety, security, protection, or convenience.

The Customer may receive service under the following plans:

Plan No. 1 (Equipment Rental Charge) -

The District will install, own, operate, and maintain the lighting equipment.

Plan No. 2 (Energy Charge) -

The District will furnish unmetered energy which will be billed on a flat monthly charge.

Billing for energy use for non-standard lighting equipment not provided for in this rate schedule shall be made in accordance with the General Service Lighting Rate Schedule.

**CHARACTER OF SERVICE:** AC, 60 hertz, single-phase, at any of the District's standard secondary voltages.

## AREA/DIRECTIONAL LIGHTING RATE SCHEDULE

(Name of Schedule)

MINIMUM BILL: One dollar (\$1.00) per month for total energy charges and/or one dollar (\$1.00) per month for total rental charges. The minimum bill for energy charges is subject to applicable Base Rate Adjustment.

### TERMS AND CONDITIONS:

1. Service will be furnished under the District's Retail Service Rules and Regulations.
2. Extensions made for service under this rate schedule are subject to the provisions of the District's "General Extension Policy for Retail Electric Services and Facilities".
3. The District's General Customer Service Charges Rate Schedule shall apply.
4. All unmetered area/directional lights installed under this schedule shall be equipped with a photo-electric control that will limit the burning time of the lighting units from dusk to daylight amounting to approximately 4,000 hours per year.
5. Usage shall be fractionalized on the actual days of service for application of a change in rate.
6. The Customer may own, install, and operate lighting units including fixtures and control equipment on its own poles. Existing Customer-owned lighting equipment installed on District-owned or District-leased poles is subject to the District's policies, procedures, and standards. All replacement parts (bulbs, photo-electric controls, etc.) for existing Customer-owned equipment on District-owned or District-leased poles will be furnished and paid for by the Customer and installed by the District at the Customer's expense. Except for municipal lighting, no new Customer-owned lighting equipment will be allowed to be installed on District-owned or District-leased poles on or after January 1, 2010.
7. The District retains and reserves the right, power and authority to modify, revise, amend, replace, repeal or cancel this rate schedule, at any time and in whole or in part, by resolution adopted by the District's Board of Directors.

TAX CLAUSE: In the event of the imposition of any new or increased tax or any payment in lieu thereof, in excess of that provided for under Article VIII, Section 11 of the Nebraska Constitution, by any lawful authority on the production, transmission, or sale of electricity, the rate provided herein may be increased to reflect the amount of such tax or in lieu of tax increase.
