MUNICIPAL STREETLIGHTING SERVICE M-1 RATE SCHEDULE

(Name of Schedule)

AVAILABLE: In municipalities and unincorporated communities in which the District is engaged in the distribution and sale of electric energy and the District provided the investment in the streetlighting system.

APPLICABLE: To all night streetlighting service (dusk to daylight) from the overhead systems conforming to the District's standard specifications.

CHARACTER OF SERVICE: The District will install (in accordance with the District's allowable investment limits), operate, and maintain the complete system and furnish streetlighting service from dusk to daylight, or approximately 4,000 hours per year.

Streetlighting Municipal Discount:

A discount of thirty-three and one-third percent (33 1/3%) shall apply on the above rates to cities and villages served at retail by the District.

BASE RATE ADJUSTMENT:

Customers located inside the corporate limits of a community, upon whose revenues the District is obligated to pay a five percent (5%) Gross Revenue Tax, will have the Base Rate (including streetlighting municipal discount) adjusted to include the five percent (5%) Gross Revenue Tax by the following formula: Base Rate ÷ 0.95.

MINIMUM BILL: One dollar (\$1.00) per month, subject to applicable Base Rate Adjustment.

TERMS AND CONDITIONS:

1. Service will be furnished under the District's Retail Service Rules and Regulations.
2. Extensions made for service under this rate schedule are subject to the provisions of the District's "General Extension Policy for Retail Electric Services and Facilities".

TAX CLAUSE: In the event of the imposition of any new or increased tax or any payment in lieu thereof, in excess of that provided for under Article VIII, Section 11 of the Nebraska Constitution, by any lawful authority on the production, transmission, or sale of electricity, the rate provided herein may be increased to reflect the amount of such tax or in lieu of tax increase.
